Our charity is run by volunteers, who love playing music.

We are all here to enjoy music-making through playing, learning & working together.

To help our organisation run smoothly, we thank you for showing:

**Respect for the Musical Directors -** by listening & not talking when instructions are being given out - by looking after your music - by clearing away at the end of sessions

**Respect for each other -** by supporting the people you play with - by being polite and helping everyone at FMC - by allowing the music sessions to run smoothly - by not distracting others

Kindness & consideration - by helping out & by thinking of other people at FMCA - by taking care with other people's instruments and belongings - by not having mobile phones out and on during sessions

**Responsibility** - by being responsible for your own safety & by looking out for the safety of others - by also following this code when representing FMC at outside events
